BULK FUELS BID SPECIFICATIONS

Sealed bids will be received at the office of the Benzie County Road Commission, 11318 Main St, P O Box 68, Honor, MI 49640 until 1:00p.m., Friday, March 29, 2019 for providing and delivering the Road Commission's yearly bulk fuel needs.

Specifications and Quantity:

Diesel Fuel: AMOCO PREMIER OR APPROVED EQUAL, ULTRA LOW SULFUR, DYED RED.
Anticipated yearly diesel usage is 150,000 gallons. The Benzie County Road Commission has a 15,000 gallon capacity diesel tank

Gasoline: 87 Octane rating, Unleaded/E-10 Gasoline blend. All fuels must meet minimum EPA standards for emissions and particulate.

Anticipated yearly gasoline usage is 60,000 gallons. The Benzie County Road Commission has a 5,000 gallon capacity gasoline tank.

Estimated yearly gallons are offered as a bidding guide and may vary from actual usage.

Bidder is to state the current price (as of noon on March 1, 2019), rack price and the cost over rack price. Bid price must include any additives, red dye and delivery to the Benzie County Road Commission garage in Honor for twelve (12) months. Bidder must provide proof of rack price with each invoice. Bidder must state the terminal location for rack pricing quoted.

Bidder must be able to deliver within 24 hours of order. Unless delivery drivers participate in site specific Class C Operator training, all deliveries will need to be made Monday thru Friday, excluding holidays, between 7:00am and 3:30pm.

Bidders must state any other conditions that may affect their ability to meet the conditions specified.

Mutual Extension Clause:

This bid, by mutual agreement of both parties, may be extended for additional one-year periods, each year hereafter. Request for contract extensions must be in writing and received by the Road Commission no later than December 1st of each year.

The Board reserves the right to reject any or all bids, waive any defect in the bids and make awards in any manner deemed to be in the best interest of the Benzie County Road Commission.
