Qualified bidders are expected to supply and install materials for this project per section 704 of the current MDOT Standard Specifications for Construction and the attached Engineer's plans & specifications. BCRC will have the crossing excavated and prepared for sheet piling installation prior to contractor arriving on site.

Plans and Specifications will be on file and available from 6:00 a.m. to 4:30 p.m. Monday through Thursday starting on **May 30, 2019** at the Benzie County Road Commission Office.
