The Benzie County Road Commission is accepting bids for tree and stump removal in 2020 until 1:00p.m., Friday, March 27, 2020. All work shall conform to the requirements of the Benzie County Road Commission, MDOT 2012 standard Specifications for Construction, Michigan Manual of Uniform Traffic Control Devices, and all applicable laws and regulations.

The BCRC will determine which trees or stumps will be cut or removed and provide the Contractor with a work order. To the extents possible BCRC will not issue work order until a reasonable amount of work is established and organized to reduce mobilization expenses. The Contractor shall be responsible for all aspects of the tree or stump removal, brush chipping, traffic control, debris disposal, and job site cleanup.

If a property owner requests to keep wood from trees removed, the Contractor may stack the wood neatly on the jobsite behind the right-of-way line.
